<b>Critical Contingency Declaration Time &amp; Date:</b>	09:30 on 22 June 2016
<b>Event causing Critical Contingency:</b>	3 <sup>rd</sup> Party damage to the First Gas 100 pipeline between Turakina Main Line Valve and Raumai Scraper Station resulting in a gas escape and a breach of the pressure threshold at Waitangirua (Wellington).
<b>Summary of actions taken to resolve event:</b>	The damaged section of pipeline was isolated and made safe and repairs have now been completed. The pipeline system has been returned to full operational use.
<b>CCO determination on Regional Critical Contingency Status:</b>	Regional
<b>Areas of transmission system affected:</b>	The First Gas 100 and 700 pipelines and associated laterals south of Turakina to Wellington and east to Hastings.
